I am Bill. E, Branscum, a Private Investigator employed by Oracle International, an investigative agency that I established following my career as a Special Agent, U.S. Department of the Treasury. As a Private Investigator, my casework relates primarily to financial matters and securities issues; I have been recognized as an expert witness with regard to Ponzi scams and pyramid scheme promotions.

This is a third party complaint regarding Fred R. Srock, a white male whose Social Security Number is 301-54-5005 and the various Ponzi scams he promotes via pyramid schemes on the Internet. He is the promoter of various scams of this nature including, but without limitation: www.1Heluva.com, www.ClickityCash.com and www.BubbleBucks.com.

Since this form is not geared toward third party complaints, I have estimated investment losses to be \$500,000. One investor claims to have invested \$300,000 although the possibility exists that she may be a shill. I represent the interests of numerous Complainants, one of whom lost \$18,000.

This is a scam operation that exhorts people to borrow money against credit cards, or mortgage their homes, to generate investment capital to pump into a Ponzi scheme. The following is a quote from Fred Srock.

"HEY - so you're not a "salesman". OK, fine. And you don't have even \$3,000. Ok, fine, but I bet you can still get it. How much would it cost you to charge \$6,000 to your credit cards. Now come on folks, honestly, you have to be NUTS not to do this! Take a second mortgage on your HOUSE if you have to - you're GOING to make more, MUCH more than it will cost you! Fred Srock"

The scam rest on the false premis that there is money to be made by clicking on web sites. Single mothers, and others similarly situated, are encouraged to believe that if they make a sizeable investment, and recruit others to invest as well, they can make an extraordinary living from home surfing the web.

I have correspondence from the promoter saying that no distributions are possible since everything taken in has been paid out.

Information about Witnesses:

A brief search of the Internet will reveal numerous complainants. I suspect that many of those listed as major investors are shills but there are numerous legitimate investors with complaints.
